NOTIFICATION

SRO 1004(I)/2022 - In pursuance of section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), the Federal Government is pleased to direct that the following amendments shall be made with immediate effect, in SRO No. 575(I)/2019 dated May 22, 2019, read with corrigendum dated September 23, 2019 and January 22, 2020, as amended and modified through SRO No. 1037(1)/2020 dated October 12, 2020, SRO 192(I)/2021 dated February 12, 2021, SRO No. 1429(I)/2021 dated November 05, 2021 and SRO No. 576(I)/2019 dated May 22, 2019, namely:

2. The Schedule of electricity tariff in the aforesaid notification no. 1037(I)/2020 dated October 12, 2020, along with further tariff rationalization by way of further adjustment notified by notification no. 192(I)/2021 dated February 12, 2021, and SRO No. 1429(I)/2021 dated November 05, 2021 shall be substituted and superseded with the Schedule of Electricity Tariffs at S-I in pursuance of determination of National Electric Power Regulatory Authority, as intimated vide letter dated March 09, 2022 read with clarification issued by NEPRA dated July 06, 2022. Any difference between the rate recommended by NEPRA and the applicable consumer tariff notified in S-I, after accounting for the tariff adjustments in this notification shall be made available by way of subsidy.
3. Subject to the amendments made through this notification, all other provisions, terms and conditions contained in 575(I)/2019 dated May 22, 2019, read with corrigendum dated September 23, 2019, and January 22, 2020, as amended and modified through SRO No. 1037(1)/2020 dated October 12, 2020, SRO 192(I)/2021 dated February 12, 2021, SRO No. 1429(I)/2021 dated November 05, 2021, and SRO No. 576(I)/2019 dated May 22, 2019 will continue to remain in full force and effect.

As per Authority's decision dated 9-Mar-22 read with clarification dated 6-Jul-22, residential non-ToU consumers will be given benefit of only one previous slab in respect of NEPRA determined "Variable Charges" whereas only protected residential consumers will be given benefit of one previous slab for "Applicable Tariff Variable Charges".

As per Authority's decision for one slab benefit in the un-protected residential consumer category slabs from 301-700, the slab rates of 201-300 slab would be used for previous slab benefit upto 300 units in respect of the NEPRA determined "Variable Charges".

As per Authority's decision residential life line consumers will not be given any slab benefit.

Under tariff A-1, there shall be minimum monthly customer charge at the following rates even if no energy is consumed.

a) Single Phase Connections:

Rs. 75/- per consumer per month

b) Three Phase Connections:

Rs. 150/- per consumer per month
